1. Product characteristics

2. Transport

in the morning or evening in order to prevent bright sunlight and transport route shall conform to specifications.

3. Rescue measures

Skin exposure: take off the polluted clothes at once, thoroughly wash the skin with soap and clean water, and then go to a doctor.

4. Method of fire protection

Foam, carbon dioxide, dry powder and sandy soil can be used to put out a fire to save life and property, however, water can be used to keep the container in fire cool. Fireman must wear fire proofing and anti-poison clothes. Anti-poison clothes must be worn in case of big fire. Fireman must operate at position with protective cover in case of big fire.

5 Storage condition

The product shall be stored in cool and ventilated warehouse. The product shall be kept away from fire source and heat source. Warehouse temperature shall not exceed 30 °C with container enclosed and it is better recommended that the storage temperature shall not exceed 25°C for low storage temperature.
